Enrollment Fee

The enrollment fee for students <u>new</u> to SouthLake Christian Academy is \$500.00.

Returning student enrollment fee schedule is as follows:

\$400 - from January 15 to February 15

\$550 - from February 16 to March 15

\$700 - from March 16 - onward

Services Not Funded by Tuition

The Academic Development Center assists those students needing additional classroom support. Please contact the school office for information about this program

The cost of tutoring for students needing additional help beyond that normally provided by the classroom teacher, or for those on academic probation is in addition to tuition.

Optional bus transportation and after school care are not included in the tuition.

Payment Terms

SLCA partners with *FACTS to offer three Payment Agreements

Agreement I: Tuition paid in full by June 1, 2018 with a 2% discount on tuition only.

Agreement II: Tuition paid in two payments -50% due by June 1, 2018 and the second 50% payment due by December 3, 2018.

Agreement III: 12-month tuition agreement plan – Payments will occur automatically June 10, 2018 through May 10, 2019.

Commitment Date: April 2, 2018 (On this date and after, the Tuition Refund Policy is effective.)

A return item fee of \$35 will be charged to accounts for returned checks or insufficient funds.

Regardless of payment terms, all tuition becomes immediately due and payable upon notification of separation.

Tuition Refund Policy

All tuition is due in full to SouthLake Christian Academy as of April 2, 2018. However, should a student withdraw or be expelled prior to January 10, 2019, an adjustment will be made against the total tuition depending upon amount paid to date, as shown below:
